The Gift of Childhood Restored

“I don’t care—I don’t want to be here!” Those were some of the first words from a child who came to Kurn Hattin five years ago. He was withdrawn, angry, and determined not to stay. He did not want to be away from his family, his home, or his friends. Kurn Hattin was an alien environment that he did not understand, nor did he want to understand it. He acted out, was recalcitrant in his interactions with staff, and was unfriendly to the other children—all from his own (later) admissions. He was not a very pleasant child at first, and this lasted for quite a while. In a more typical independent school, this type of student likely would not have lasted long at the school, but at Kurn Hattin, this is our particular mission.

I watched as this young man, Jacob Edwards, stood up in front of the audience at graduation this year to deliver his Valedictory Address—confident, successful, and comfortable in his life at the Homes and the world. Over the course of five years, he had been *transformed*, and he was thankful for it! His trajectory in life had indeed been changed by coming to Kurn Hattin.

This is the outcome for which we all strive at the Homes—the gift of childhood being restored, lives changed, and knowledgeable, thankful hearts taking flight for greater success in life! During the hard, uncertain work of daily interactions with children, we maintain optimism because we know these transformations occur, but not all at once. The process of change is often slow, agonizingly so sometimes, and it is almost never on a consistent upward linear path—but it happens. Over and over again, we watch it occur, child by child, and so we continue our endeavors with the confident knowledge that we are doing the most important work in the world—transforming children!

We are fully aware that this requires on-going support from like-minded individuals who provide the resources for each of these singular transformations, and we are thankful. Please accept our profound gratitude for being a partner in each child’s life here at the Homes!



Miracles of Transformation



Annual Report from the Financial Manager

Throughout this report there are examples of the transformative impact on the children attributable to their time at Kurn Hattin. This is only possible through the commitment and hard work of the staff and the generosity of donors, who continue to make it possible for Kurn Hattin to achieve this impact on children. As noted in the financial report on the next page, approximately 95% of Kurn Hattin's income is from philanthropic sources. This includes the endowment, annual contributions to support operations, and income from outside trusts established by donors over the years to provide annual income.

The importance of the endowment to fulfilling Kurn Hattin's mission cannot be overstated. Donor support for the endowment in Fiscal 2018 totaled \$1,165,157, in the form of gifts and bequests. The invested funds achieved a 7.2% positive return as of June 30, 2018. Kurn Hattin's Investment Committee is comprised of board members, staff, and four outside investment professionals, who along with our investment advisor Prime Buchholz meet at least quarterly to review investment performance. This volunteer committee works hard to make sure that Kurn Hattin's endowment is in the best position to achieve growth and to support Kurn Hattin's operations. Building the endowment through positive investment performance and new gifts is an ongoing priority. As of June 30, 2018 the endowment stands at \$45.9 million.

Fiscal 2018 was positive with respect to the operations of Kurn Hattin. Collectively, budget managers underspent the budget by \$158,000 or 3%. Capital expenditures in Fiscal 2018 totaled \$150,000, which included a new roof surface on the Mayo Center, renovation work on Ball Cottage, and repair and resurfacing a section of road on campus. Road repair and resurfacing continues to be a major priority, with projects in July and August to redo the main roads on campus.

Our Financial Statements are examined by the firm of Oster & Wheeler of Keene, NH, a certified public accounting firm. Audits are conducted annually in accordance with generally accepted auditing standards and include an assessment of accounting principles used as well as an evaluation of our financial procedures, controls and presentations. The audited statements may reflect different classifications than presented above and will reflect investment unrealized gains or losses.

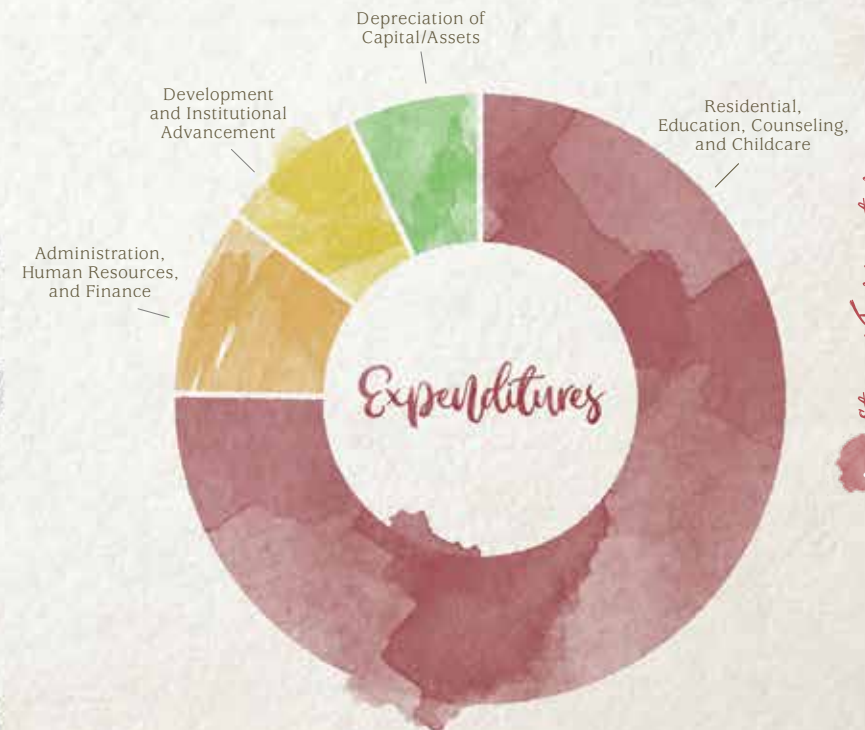
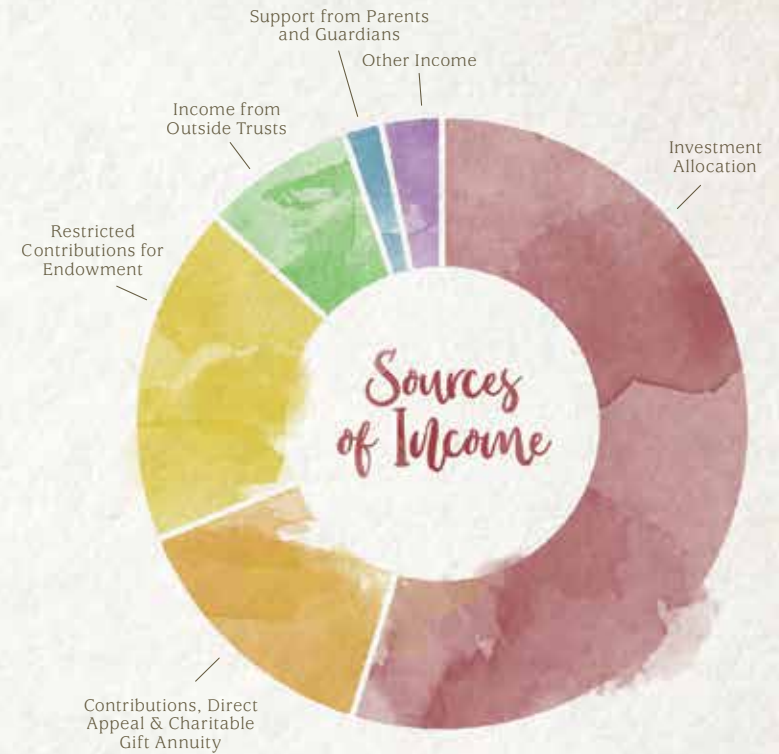
