The children are the focus of everything we do at Kurn Hattin Homes. When we are considering programmatic and/or organizational changes to systems and structures, it always comes back to what would be in the best interest of the children. The Child Experience Committee was formed by the Board of Trustees in 2019 with exactly this intent—to focus on all the areas of what we do for the children in our care—residential, school, counseling, health services, admissions, outreach, and more—with the goal of providing them the best experiences and opportunities that we can in every way.

The central question for this Committee is whether we are being true to our mission while delivering the best possible experience to prepare each child to be successful for life beyond our campus. This means that the Child Experience Committee has been considering what success actually means for our KHH children. A second part of the work, once we can more clearly define the concept of success, is to determine how we measure that success. There are some metrics that we're asked about repeatedly that we have data on and can provide accurate answers to those questions. For example, how many of our alumni graduate from high school, join the military, go on to a trade or vocational school, get an Associate's Degree, graduate from college, and so on. Then there are the more intangible aspects of life that are very much a part of success and that are very challenging to define and to measure.

Right now, daily successes at KHH vary from child to child. During the summer rec program, individual successes meant things like demonstrating self-control while you wait for your turn to jump into the pool, learning to tie your shoe, catching a fish, helping a cottage mate do a chore, riding a bike without training wheels for the first time, or picking a full pint of blueberries all by yourself. The successes are as varied as the children themselves.

Our goal is for them to have fun and to experience things that will provide lifelong memories. At the same time, we want them to learn the key skills that they will need to navigate the world around them and to live independent lives.

There are so many intangibles involved in the consideration of all of this. Being productive citizens, having happy family lives, being able to support themselves, contributing in some way to the world around them, finding their passion and pursuing it, developing self-awareness, and knowing how to advocate appropriately for themselves in all kinds of situations are a small sampling of the skills we hope they will have when they leave KHH. How do we measure this? That is part of the ongoing work of the Child Experience Committee.



The theme of caring and success in financial terms is reflected in the **investment** and **COMMITMENT** of financial resources to provide the children with the best possible experience while at Kurn Hattin Homes. In Fiscal 2022, this included enhancing the technology on campus through the extension of the fiber network to all buildings, new computers for the students to use in their classrooms and cottages, and a new smart lab in the school. Ongoing improvements to the facilities and campus provide the kids with the best possible environment. This also included window replacement in the cottages, road paving, and a new state of the art HVAC control system in the school to regulate air temperature and air guality. The health and wellbeing of the children are also a resource priority. The most significant investment affecting the children's wellbeing is in our staff. This past year there has been extensive staff training in a number of areas, a significant restructuring and improvement in the compensation for houseparents, and upgrades to staff computers.

Fiscal 2022 was also a year of challenges for Kurn Hattin Homes. Most notably was the decline in the investment market, and the impact on the endowment resulting in a -9.6% return for the fiscal year. We also experienced significant storm damage around the water pump house costing approximately \$61,000 to repair.

Charitable giving totaled \$2.7 million in Fiscal 2022. The financial support from donors continues to make it possible to positively impact the lives of children and their families. Gifts to the endowment, annual contributions, estate gifts, and outside trusts established by donors to provide annual income have made it possible to sustain Kurn Hattin Homes. As noted in the financial report on the next page, approximately 94% of Kurn Hattin's operating income is from philanthropic sources. This sustainability will continue to depend on building the endowment through new gifts and annual donor support.

Financial Disclosure: The purpose of the Financial Annual Report is to inform the public and contributors of the financial position of the organization and to acknowledge and recognize the support of our Trustees and Contributors.

Our Financial Statements are examined by the firm of Oster & Wheeler of Keene, NH, a certified public accounting firm. Audits are conducted annually in accordance with generally accepted auditing standards and include an assessment of accounting principles used as well as an evaluation of our financial procedures, controls and presentations.

Copies of the audited statements are available upon request at the Kurn Hattin office in Westminster, VT. The audited statements may reflect different classifications than presented above and will reflect investment unrealized gains or losses and other non-operating activity.


