Cwtch

Even though "cwtch" has no literal English translation, I have loved the word from the very first time I heard it. It is an intrinsically Welsh word that evokes a sense of home.

My understanding of cwtch is that it means a warm embrace, a hug. It has a second meaning that refers to a cubbyhole or a cupboard, a small space where you can store things safely. If you combine those two meanings, it gives you a better idea of what the word actually means.

Kurn Hattin Homes is such a place. Our children feel loved, cared for, seen and heard, safe and secure. We are their cwtch. All of us at KHH wrap our arms around the children in different ways, yet everyone's goal is to give them the warm, comforted, and cared for feeling that a person gets when they are at home.

One of the things that I have always loved about KHH is that we are clear that first and foremost we are a home. A home first, before we get to our topnotch academic programs, and all the incredible opportunities that we provide for the children in our care.

The world around us can be tumultuous. Home provides an anchor, a constant. We tell our alums that we are here for them, and we are, waiting with open arms to be their cwtchjust as we are for every one of the children enrolled right now.


It's the idea of wrapping your arms around someone to make them feel safe in the world, at home. It can be a person or a place that makes you feel this way.


A simple definition of Home is "it is where you live." While simple and easy to understand, I'm not sure it's accurate. I "lived" at college for four years, but never considered it my Home. I'm sure most of you have some similar experience. So what is it that makes Kurn Hattin a Home?

I went around my office asking the guestion, "What is Home?" This is what I heard: Home is a safe and secure place; it has the necessities and the things you enjoy; it is where you find the people you care most about and who care most about you-family; it is where you are comfortable, relaxed, and at ease; it is where you find memories and pieces of yourself; it is a place you come back to; and my personal favorite, it is where you can be yourself and people will love you regardless. It was clear that "four walls" do not define a Home.

Based on those elements, is Kurn Hattin a Home to our children? I believe it checks many of the boxes, which is especially important given what many of our children have experienced at an early age. So yes, Kurn Hattin is a Home to our children. Is Kurn Hattin's intention to replace our children's family Home? It is not. Our role is to provide a Home for our children while under our care to fulfill our mission to "Transform the lives of children and their families forever" by providing a safe, stable, nurturing environment where our children can grow into solid, well rounded people and family members outside of Kurn Hattin. This is the type of work that can only be done at Home.

We are very mindful that everything we do at Kurn Hattin Homes is in support of making it a home for children where they can flourish and succeed. Every year there are ongoing improvements to the Homes' facilities and campus to provide the children with the best possible environment. In Fiscal 2023, this included renovations for the new SmartLab, providing space for counselors and nursing staff to have more direct access to students during the school day, and new office space for the Principal and administrative staff. There was a significant upgrade to the school auditorium, including new stage curtains and backdrops, lighting, and sound systems. Maintaining the cottages with upgrades to the flooring, windows, bathrooms, and fresh coats of paint is a priority each year. Capital improvements totaled \$304,269 this past fiscal year.

What we do to make Kurn Hattin the home we are proud to provide the children only happens with the generosity of donors. Charitable giving totaled \$3.98 million in Fiscal 2023. Gifts to the endowment, annual contributions, estate gifts, and outside trusts established by donors to provide annual income has made it possible to sustain Kurn Hattin. As noted in the financial report on the next page, approximately 98% of Kurn Hattin's operating income is from philanthropic sources. Kurn Hattin's sustainability will continue to depend on building the endowment through new gifts and annual donor support.


